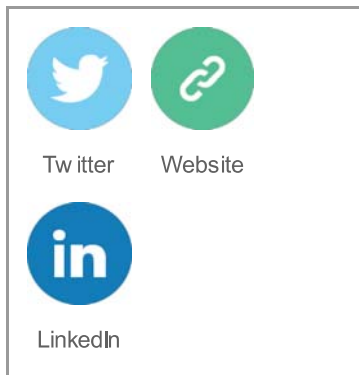
About SFBTA
