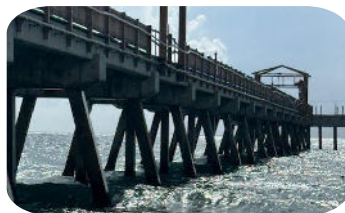
From the Founder's desk

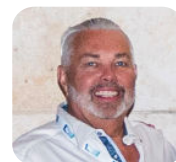
Community Work Day
